We live, work, educate our children and raise our families here. We employ non-tribal members with our various enterprises and we welcome visitors to the Community.

We have every reason - - indeed a vested interest - - in ensuring that our Community is a safe and healthy place for our members, our employees and our visitors.

The Salt River Police Department has an excellent working relationship with all surrounding police agencies and jurisdictions. This is built on our mutual mission of service to the Communities we serve. This cooperative relationship extends to cases where outside police agencies seek extradition of individuals from the Salt River Pima-Maricopa Indian Community (SRPMIC) who have felony warrants from outside jurisdictions.

Extraditions are conducted with regularity at the Salt River Police Department, in accordance with SRPMIC Law. Cooperation in the presentation of required documentation of the <u>demanding jurisdiction</u> is an essential element to begin the process and makes for a streamlined overall procedure.

The Salt River Police Department is resolute to providing assistance to any Law Enforcement Officer or Agency upon their request and when the alleged offender is Native American. Based upon legal standards our Officers may arrest or take disposition of an investigation or conduct an extradition process.

Since 1996, we have conducted about 25 adult extraditions and 3 juvenile extraditions.

Process, Chapter 7:

- 1. Demanding jurisdiction has an arrest warrant (any felony crime).
- 2. If in custody, SRPD obtains FOJ warrant trough SR Court. Held up to 30 days.

- 3. If at large, SRPD obtains FOJ warrant and searches for suspect.
- 4. SRPD contacts MCSO Fugitive Extradition Unit.
- 5. MCSO prepares request packet for AG's Office that includes positive ID (prints photos) of suspect.
- 6. Vince Talino (AG's Office contact) prepares document certifying accuracy of packet/documents to be sent to Governor's office.
- 7. Governor reviews and upon approval of the Governor, signs off on the extradition packet.
- 8. Packet is returned from AG's Office to SRPD, we prepare report and history packet to be provided to the SRPMIC President.
- 9. SRPMIC President reviews and upon approval of President, signs off on Arrest Warrant/Order of Extradition.
- 10. Suspect is served with Arrest Warrant/Order of Extradition and is arraigned in the SRPMIC Tribal Court.
- 11. Suspect can contest, however, to date, Tribal Court has upheld all such extradition cases.
- 12. Suspect is remanded into the custody of the MCSO Fugitive Extradition Unit who then books them into the MCSO jail for the outstanding charges.
