SUMMARY:

On 10-04-00, Agent/Officers of the Hoopa Tribal Police Department (HTPD), assisted by Agents from the Humboldt County Drug Task Force (HCDTF), Deputies from the Humboldt County Sheriff's Department Drug Enforcement Unit (HCSO), and the California Highway Patrol (CHP) served search warrant number 4599 at the Harold Harry CAMPBELL, Jr., residence at Beaver Creek Road, Hoopa, California.

A search of the residence revealed 11 handguns, 17 rifles, five shotguns (some loaded), \$9,300, 723.5 grams of packaged marijuana buds, scales, packaging material, indicia in the name of Harold CAMPBELL, Jr., suspected pay and owe records and two computers.

Located outside the residence were 21 drying marijuana plants and scales in the upstairs garage. Several large marijuana plants were found in the greenhouse and several large marijuana plants were found planted in the surrounding forest, for a total of 236 live growing marijuana plants.

Harold Harry CAMPBELL, Jr., was taken into custody for the following violations: H&S 11358, unauthorized planting, cultivating, or processing of marijuana; H&S 11359, possession for sale of marijuana; H&S 11366, maintaining place for unlawfully providing controlled substance; and H&S 11370.1, possession of controlled substance and firearm.

Harold Pliny CAMPBELL, DOB 07-23-78, arrived at the residence and was taken into custody for a felony warrant for possession of methamphetamine.

DETAILS OF INVESTIGATION:

1. On 09-26-2000, I obtained search warrant 4599 signed by the Honorable Judge Dale Reinholtsen of the Humboldt County Superior Court. The search warrant listed marijuana and associated items to be seized, and ordered the search of the residence and person of Harold Harry CAMPBELL, Jr., at Beaver Creek Road, Hoopa, California.
2. On 10-04-2000 at about 0900 hours, I met with Sergeant Colegrove, Officer Brooks (HTPD), Sergeant Hanson, Deputies Cooper, Garcia, Reserve Anfinson (HCSO), Agents Olson, Kirkpatrick, Morgan, O'Neill, Nova, Rybarczyk (HCDTF), Officers Sherman, Lobec (CHP Air Operations). I conducted an operational briefing at a predetermined location for the service of a search warrant at the Harold Harry CAMPBELL, Jr., residence on Beaver Creek Road in Hoopa, California. Assignments were given at that time.
3. At about 1005 hours all personnel arrived at the CAMPBELL residence. With the CHP helicopter overhead, I knocked on the front door and yelled, "Police; search warrant; open the door." After several seconds and receiving no answer, I knocked on the front door again and yelled, "Police; search warrant, open the door." After waiting and still receiving no response, I checked the doorknob and found that it was unlocked. Agents Olson, Kirkpatrick, O'Neill, Rybarczyk, Morgan, Nova (HCDTF), Deputy Cooper (HCSO), Investigator Mohon (HTPD) and I entered the residence and went from room to room continually announcing our presence and purpose.
4. The first floor of the residence was searched and no persons were located. Agents, Deputy Cooper, Investigator Mohon and I then searched the second story. The second story consisted of four bedrooms and a bathroom. Located in the upstairs bathroom was Sam CAMPBELL, DOB 11-17-81. Sam identified the southeast bedroom as his. I escorted Sam into his room and I stood by while he dressed. I escorted Sam downstairs to the living room where he was seated.

5. Sergeant Hanson, Deputies Garcia, Anfinson, located Harold CAMPBELL outside the residence near a chicken coop. Attached to the chicken coop was an exterior shelf. On the shelf were several black grow pots. In each of the pots was a 12-inch growing marijuana plant. On the ground near the chicken coop were three plastic 20-gallon containers. Located in each container was one large four-foot growing marijuana plant. Approximately ten feet from the chicken coop was a plastic greenhouse approximately 8 x 24 feet. Inside the greenhouse were several 2 to 5 feet large growing marijuana plants. All the marijuana plants located on the shelf, in the 20-gallon containers and in the greenhouse were in the budding stage of growth.
6. Harold was detained in handcuffs and escorted into the residence by Deputies. I identified myself to Harold, who I know from prior contacts. I showed Harold a copy of the search warrant. Harold agreed to show me around the residence. Harold identified the upstairs northwest bedroom as his. Harold pointed to several firearms located in a gun case in the living room, a Glock handgun located in the china hutch in the kitchen. In his bedroom he pointed out several items, a green Pelican case that contained package marijuana inside, several firearms, U.S. currency located in a ceramic breast, and a doctors note. Harold was then seated outside on the front stairs.
7. Agent Kirkpatrick video-taped the interior and exterior of the scene. Agents Rybarczyk and O'Neill photographed the residence and surrounding area. Agents, Deputies, Investigator and I proceeded to search the residence.
8. Located inside the residence were 11 handguns, 17 rifles, five shotguns (some loaded), \$9,300 in U.S. currency, packaged marijuana buds, scales, packaging material, indicia in the name of Harold CAMPBELL, Jr., suspected pay and owe records and two computers, among other items. Refer to the evidence section of this report for complete details and locations of evidence collected. Also refer to Agent Morgan's sketch of the interior layout of the residence.

9. Deputy Cooper (HCSO) assisted with the collection and processing of the marijuana plants and associated items located outside the residence. Refer to Deputy Cooper's report # 00-12873.
10. At about 1115 hours, Agent Rybarczyk and I spoke with Sam CAMPBELL, Harold's son. The conversation was recorded on a standard size audio cassette. Agent Rybarczyk spoke with Sam first. Refer to Agent Rybarczyk's supplemental report, number 3, for details of their conversation.
11. At about 1121 hours, I spoke with Sam. I identified myself and told Sam I would be advising him of his rights per Miranda from a card supplied by the district attorney's office. I told Sam that I would need him to verbally answer the questions with a "yes" or a "no" answer after each notification. At the conclusion of the reading of the Miranda rights, Sam answered "yes" to each question and he agreed to talk with me. The following is a synopsis of the interview.
12. I told Sam I was serving a search warrant. I told Sam in talking with Agent Rybarczyk he said he lived at the residence. I told Sam when I came in, I found him in the bathroom. Sam stated he lived at the residence and was there all the time.
13. I told Sam the marijuana is real close to this house. Sam said his father never told them anything about his business, we knew he was growing out there, but he never told us what for, why, when or where. He never watered any of the marijuana plants before or ever did anything with the marijuana. He didn't bother any of his father's stuff, because his father wanted it that way. Sam also stated that his father didn't want the kids bothering anything outside.
14. I asked who else lived at the residence. Sam stated his sister, Mary CAMPBELL, and his brother Harold. I asked Sam if there is anybody else who lives inside this residence. Sam stated no.

15. I asked Sam if his father has ever asked him to get him marijuana, or if he had seen any other drugs in the house. Sam stated no, that he usually stayed upstairs in his room and he only knew his father used Valium.
16. I asked Sam if he knew anything about any of the marijuana outside, or the packaged marijuana located inside the residence. Sam stated no.
17. I asked Sam about the scissors and clippings found on the table in back room, and if he had clipped marijuana before. Sam said he had seen his father trimming before, but you probably call it manicuring.
18. Agent Rybarczyk asked where his father usually manicured and when was the last time he saw his father manicuring. Sam stated in the room with the pool table. The last time he saw his father clipping marijuana was a month ago.
19. Agent Rybarczyk asked if his father gave marijuana to other people. Sam stated he saw his father give marijuana to other people, but did not know how much, but that it was in small bags. I asked Sam if it was always in bags. Sam stated yes. I concluded the conversation at 1132 hours.
20. At about 1147 hours, Agent Rybarczyk and I met with Harold Harry CAMPBELL, Jr. Agent Rybarczyk talked to Harold CAMPBELL first about the money that was located inside the residence. I then read him his rights per Miranda from a card supplied by the district attorney's office. At the conclusion of the reading of the Miranda rights, Harold at first said he wanted to speak to an attorney, then said he would answer selected questions as long as he could say no anytime he wanted. The following is a synopsis of the interview.
21. Agent Rybarczyk told Harold he could make it easy for him. If Harold wanted an attorney, we could stop talking right now, or he could selectively answer those questions he wanted. Agent Rybarczyk told Harold he wanted it clear in his mind, what he wanted to do, and that he did not have to feel obligated to

- speak with us. Harold stated he didn't really want to talk about the marijuana. Agent Rybarczyk asked about the scales that had been found. Harold stated he used the scales to keep track of marijuana.
22. Agent Rybarczyk asked Harold how he kept track of the money owed to him, and if he used a ledger or receipt book. Harold stated, "I don't. People just owe me."
 23. Agent Rybarczyk asked Harold if his kids were involved. Harold stated, "No." Agent Rybarczyk asked how he kept it away from his kids. Harold stated, "I rather they smoke joints than drink beer."
 24. Agent Rybarczyk asked Harold how long he had been growing marijuana. Harold stated he had been growing for one year.
 25. Agent Rybarczyk asked Harold about the firearms. Harold stated that some of the firearms belong him and others were his friends.
 26. I asked Harold about the doctor's note he showed me in his room and when was the last time he saw his doctor. Harold stated, "A year ago, before he (the doctor) got busted for murder. He prescribed it back in 1998."
 27. I asked Harold how many plants were there at the house. Harold stated, "There's about 75 growing" and he gets about 3/4 of an ounce from each plant.
 28. I asked Harold about the packaged marijuana inside the residence located in the boxes and if it was his. Harold nodded his head up and down and then stated, "Yes."
 29. Agent Rybarczyk asked Harold if he climbed up the ladder in the garage and if he had hung the drying marijuana. Harold didn't answer. The interview was concluded at about 1200 hours.





On 04-06-99, Agents from the Humboldt County Drug Task Force (HCDTF) and officers from the Hoopa Tribal Police Department (HTPD) served a search warrant for Ronald Wayne GREEN, his vehicles, and his residence.

During the search of GREEN, Agents found 29 individually packaged bags of suspected methamphetamine and a large amount of U.S. currency.

During the search of his vehicle, a white 1998 Toyota pickup bearing California license 5U09442, Agents found an unloaded 9mm handgun.

During the search of the residence, Agents found approximately 25.95 grams GFW of suspected methamphetamine, scales, pay and owe sheets, a .22 caliber handgun, and a large sum of U.S. currency.

DETAILS OF INVESTIGATION:

served at Ronald GREEN's residence on Marshall Road, Hoopa. Assignments were given at that time.

3. Surveillance was conducted in the Hoopa area for GREEN. At approximately 1020 hours, Agent Kirkpatrick and SAS Olson observed GREEN drive out of the Ray's supermarket parking lot onto State Route 96 in the white 1998 Toyota pickup bearing California license #SU09442.
4. Officer J. Hostler conducted a traffic stop on the vehicle on northbound State Route 96 south of Big Hill Road. Officer Hostler and Kane approached the right side of the vehicle. Agent Kane observed GREEN as the solo occupant/driver. Officer Kane yelled to GREEN, "Put up your hands!" GREEN was yelling, "Why, why" as he began to roll up the driver's window.

14. Agents located a 1996 Suzuki 2F900R motorcycle in the living room. The motorcycle was seized pursuant to asset forfeiture proceedings.
15. Agents left and secured the residence at 1310 hours.
16. At approximately 1600 hours, Agent Morgan received the clothing of Agent Kane, collected as evidence by District Attorney Investigator Scott Smith, from R. Garcia-Young.

On 1-28-99 Agent Kane conducted an operations briefing at the Hoopa Tribal Police Department for the service of the search warrant. Assignments were given and all personnel were dressed in distinctive police uniforms.

At approximately 1600 hours Agents, Officers arrived at the Simpson residence (location #1). SA Kirkpatrick knocked on the front door and yelled "Police search warrant, open the door" after several seconds and no answer from within the residence. SA Kirkpatrick again knocked on the front door and yelled "Police search warrant, open the door". After several seconds and no answer from within the residence. SA Kirkpatrick knocked on the front door and yelled "Police search warrant, open the door" for a third time.

The door opened and Agents Kirkpatrick, Cummings, Morgan, Kane and Officer Colegrove made entry into the residence. Vivian and her grand daughter Tianna were detained by Agent Kirkpatrick and Morgan, as SA Cummings, Kane and Officer Colegrove went from room to room, continually announcing their presence and purpose. No other person were located inside the residence.


